- ii. An experience in the International Trading of Chemical Fertilizer, within the immediate past one (01) year to the date of the submission of the bid.
  - iii. Minimum annual turnover of US\$ 25 million from the International Trading Business in the immediate preceding financial year.
  - iv. In the case of foreign bidder, a local representative/ local agent in Sri Lanka should represent on behalf of the principal.
