- Overall capacity and competence of the firm to carry out the assignment.

Conflict of Interest

Interested consulting firms should note that the World Bank's Procurement Regulations for IPF Borrowers, July 2016 (revised November 2023) set forth the World Bank's policy on conflict of interest.

In addition, please refer to the following specific information on conflict of interest related to this assignment: The selected firm or any affiliate that directly or indirectly controls, is controlled by, or is under common control with that firm, shall be disqualified from providing consulting services, financed by the Project. Further, consultants, suppliers, contractors and service providers (including their experts and other personnel), that have a close business or family relationship with all staff assigned under this contract and the key personnel of the selected firm shall not be financed by the project.

Associations

Consulting firms may associate with other firms in the form of a joint venture (JV) or as sub-consultants to enhance their qualifications. A firm may associate with other firms but shall submit only one Expression of Interest. Shortlisting will be based on the qualifications of the firm or the JV.

Selection Method

A consulting firm will be selected in accordance with the Quality and Cost-Based Selection (QCBS) method set out in the World Bank Procurement Regulations.
