The Chairman, Standing High Level Procurement Committee (SHLPC) on behalf of the Secretary, Ministry of Agriculture, Livestock, Land and Irrigation invites sealed bids from eligible fertilizer suppliers (Manufacturers, Principals or Accredited Agents and Local Traders) for the supply of 10,000+/-5%Mt. of Urea (Prilled) & 10,000+/-5%Mt. of Urea (Granular), in accordance with the **CIF basis under the payment terms of irrevocable Letter of Credit (LC terms)** to the State Fertilizer Company Limited., as per the details given below:

02. The eligible bidder should be fulfilled the following requirements;

- i. All bidders shall possess legal right to supply the Goods under this contract.
- ii. The bidder should submit a scanned (coloured) copy of the Registration/incorporation documents issued by the relevant authority to demonstrate that it is a legally established business entity in its country of origin registered as a business with the appropriate authority in the respective country for a minimum period of three (03) years to the date of the submission of the bid.

- iii. An experience in the International Trading of Chemical Fertilizer, to any country within the immediate past 02 years to the date of the submission of the bid. The local traders shall demonstrate experience in supplying chemical fertilizers to Sri Lanka during the two (02) years preceding the bid submission date.
- iv. In the case of foreign bidder, a local representative/ local agent in Sri Lanka should represent on behalf of the principal.
- v. In case of Local Traders should have a valid import license issued by the National Fertilizer Secretariat (NFS).
- vi. A Bidder that is under a declaration of ineligibility by the Public Finance Department of the Ministry of Finance, Planning and Economic Development / National Procurement Commission (NPC) at the date of submission of the bids or at the date of Contract award shall be disqualified.
- vii. A Bidder shall not have a conflict of interest. All bidders found to have conflict of interest shall be disqualified. Bidders may be considered to have a conflict of interest with one or more parties in this bidding process, if they are or have associated in the past, with a firm or any of its affiliates which have been engaged by the purchaser to provide consulting service for the preparation of the design, specification and other documents to be used for the procurement of goods to be purchased under these procurement documents.

The Bid Security Guarantee required to submit by the bidders to the value of US\$ 50,400.00 for Bid No. MoA/SFCL/URP&G/ICB/2026-02 –Prilled, US\$ 52,500.00 for Bid No. MoA/SFCL/URP&G/ICB/2026-02 –Granular and value of US\$ 102,900.00 for both urea (Prilled) and Urea (Granular), issued by the license commercial Bank registered with the Central Bank of Sri Lanka and valid upto **02.12.2026** (96 days from the date of opening) in favour of The Secretary, Ministry of Agriculture, Livestock, Land and Irrigation (Agriculture Division), No. 80/5, “Govijana Mandiraya” Rajamalwatta Road, Battaramulla, Sri Lanka.

Local traders shall be permitted to submit the Bid Security Guarantee in Sri Lankan Rupees (LKR) value of LKR 17,153,000.00 for Bid No. MoA/SFCL/URP&G/ICB/2026-02 –Prilled, LKR 17,868,000.00 for Bid No. MoA/SFCL/URP&G/ICB/2026-02 –Granular and value of LKR 35,021,000.00 for both urea (Prilled) and Urea (Granular), issued by a licensed commercial bank registered with the Central Bank of Sri Lanka and valid upto **02.12.2026** (96 days from the date of opening) in favour of The Secretary, Ministry of Agriculture, Livestock, Land and Irrigation (Agriculture Division), No. 80/5, “Govijana Mandiraya” Rajamalwatta Road, Battaramulla, Sri Lanka.

A complete set of Procurement documents in English language could be purchased by the interested bidders from the Acting Manager (Procurement & Imports) of the State Fertilizer Company Limited., on payment in cash of a non-refundable bidding fee of **LKR 250,000.00 (Sri Lankan Rupees Two Hundred & Fifty Thousand only)** per set of Procurement document.

06. When collecting the procurement documents the representative must be present a duly authorized letter certifying that he or she is the supplier’s local representative by the principal supplier.

07. Procurement documents will be issued on any working day, **between 9.30 a.m. and 3.30 p.m., from 06.08.2026 to 25.08.2026.**

08. Bidding will be conducted through International Competitive Bidding Procedure (ICB).
